

CLIENT AGREEMENT

Card Authorization and Travel Insurance Confirmation

This Client Agreement | Card Authorization and Travel Insurance Confirmation ("Agreement") is made as of the signature date below.

BETWEEN: Imagine Travel ("Agency," "our," "us," or "we")

AND: You and all minor and adult Travelers on the same Booking who reside in your household ("you" or "your").
(each a "Party" and, together, the "Parties").

This Agreement includes the Terms and Conditions ("Terms") at <https://www.imaginetraveltvacations.com/> ("Website").

The Parties agree as set out below.

Capitalized words not defined in this Agreement have meanings as set out in the Terms.

CLIENT AGREEMENT

1. This Agreement and the Terms become effective and binding on each Traveler upon the earlier of: (a) your written, digital, or electronic signature or other acceptance; or (b) your Booking, payment toward, or use of Travel Services. This Agreement and the Terms remain in effect until terminated upon a Party's written notice of termination to the other Party.
2. The Terms are subject to change at any time in Agency's discretion, without notice to you. Changes become effective upon the earlier of: (a) your written, digital, or electronic signature or other acceptance; (b) your Booking, payment toward, or use of Travel Services; (c) our written notice to you; or (d) publication at <https://www.imaginetraveltvacations.com/>.
3. You confirm that you are 18 years of age or older and have authority to sign and accept this Agreement and the Terms on behalf of all minor and adult Travelers on the same Booking who reside in your household.
4. You confirm you are responsible and liable for the acts and omissions of all minor and adult Travelers on the same Booking who reside in your household, as if they were your acts and omissions, and you agree to indemnify us as set out in the Terms.

CARD AUTHORIZATION

By submitting any credit or debit card ("Card") to us, you confirm that: (1) you are an authorized user of that Card; (2) you authorize us to charge the Card as agreed in your Trip Documentation; (3) you authorize us to credit the Card for amounts charged in error; and (4) you agree to all chargeback policies set out in the Terms.

TRAVEL INSURANCE CONFIRMATION

1. Agency is NOT an insurance agent or insurance provider. Our role is to advise you of the availability of travel insurance, which third-party insurance agents and insurance providers offer to you in exchange for fees. We recommend buying travel insurance to cover each Traveler.
2. You understand your travel may involve: (a) unexpected events and inherent risks; (b) fees for changes and cancellations; and (c) other expected and unexpected costs, some of which may be NON-REFUNDABLE.
3. You waive all claims against Agency, its owners, directors, employees, contractors, agents, representatives, advisors, successors, and assigns (collectively, "Agency Parties") and you indemnify and hold harmless Agency Parties for and from all damages, losses, costs, injuries, and deaths relating to: (a) your decision to buy or decline travel insurance; (b) any insurance policy you buy; or (c) any claim your insurance provider may deny.
4. You are responsible for deciding to buy or decline travel insurance, as confirmed below (please choose ONE option). Your decision applies to you and all minor and adult Travelers who reside in your household.

☐ **OPTION 1: I AGREE TO BUY TRAVEL INSURANCE**

By agreeing to buy travel insurance, you understand and agree as set out below.

1. You will read each travel insurance quote, policy, and coverage offered to you.
2. You are responsible for understanding all details regarding your travel and any corresponding insurance policy.
3. Your insurance coverage includes only those things expressly stated in each policy.
4. Insurance policies may include pricing and restrictions based on such matters as the time of purchase and the type and location of travel.
5. Insurance policies may exclude coverage for such matters as pre-existing medical conditions, inherently risky activities and locations, and interruptions relating to unexpected events, including pandemics or epidemics.
6. You will pay for travel insurance by: (a) following Agency's directions to make payment directly to an insurance agent or insurance provider; or (b) authorizing Agency to charge the quoted amount to your credit or debit card.

☐ **OPTION 2: I DECLINE TRAVEL INSURANCE**

By declining travel insurance, you understand and agree as set out below.

1. You accept all risks relating to your travel.
2. You decline all insurance coverage relating to your travel, including without limitation protection against changes and cancellations; delays, damage, and losses regarding your baggage, valuables, and other property; supplier defaults; accidents, emergencies, and other unexpected events; illnesses, injuries, and deaths; and all other damages, losses, and costs relating to your travel.
3. You may lose up to 100% of the cost of Bookings and you may be required to pay additional fees relating to changes or cancellations charged by Agency and third-party suppliers.

If you have not received information regarding travel insurance, or if you do not understand any part of this Agreement or the Terms, you agree to contact us before acceptance by your signature below. You confirm you have read, understand, and accept this Agreement and the Terms.
